Terms and Conditions Privacy Policies and treatment of personal data Cookies use policy

Thank you for your interest in CityScan and TourMakers, the platform to create, publish, sell and enjoy unique tourist experiences in a virtual and face-to-face way. We appreciate your interest in our services and we welcome you. You are entering into a binding contract with the legal person specified at the end of this document. Please read these terms and conditions of use carefully so that you understand the purpose, scope of the website and related applications and rules on the access and management of it. By using and / or accessing any section of the CityScan mobile application and / or website, services operated by Info Projects SAS, it is considered that you, hereinafter referred to in the document as "User", are obliged to comply with (i) these terms and conditions, (ii) our privacy and personal data processing policy and (iii) our cookies policy. It is understood that the user has accepted and understood all the terms and conditions, privacy and cookie policy from the moment they enter and register on the CityScan website or related applications, referred here generically as CityScan. Carefully read all the general conditions, if you decide not to accept them, do not enter the mobile application or its website.

TERMS AND CONDITIONS

Purpose of the service

The user knows that the CityScan platform provides a private service that allows creator users (TourMakers) to create, publish and sell content related to places and tours and allows search users (TourFinders) to search, identify and enjoy the contents of the places and tours available. For the search and identification of places and tours, the application uses the position, orientation and display of information related to places or tours georeferenced, registered, classified and located in a defined spatial radius. The user knows that CityScan uses augmented reality (AR) technology and a georeferencing system (GPS). In addition, the user knows that the service provided by CityScan is carried out through the mobile applications and / or website owned by the service provider. CityScan will be responsible for the quality, relevance and assertiveness of its services.

Service access requirements

You may access and use this website or related applications (Site / Apps) if you are of legal age in accordance with applicable laws. Additionally, the user declares that they have the physical and mental capacity to access the service. If you are not of legal age or do not have the legal authorizations and capacity required to access and use this service, Site / Apps, please refrain from using CityScan.

Autonomous account management

CityScan allows all its users to choose their username and password. Customers must keep such information in the strictest confidentiality, since they are responsible for the operations carried out within their CityScan account. If at any time, the user considers that a third party knows his username and / or password, the customer must change them immediately through the website or mobile application. In case you forget part or all of your combination, please contact us. If the user misplaces, forgets, loses or shares their username and / or password with a third party or is unable to access the Site / Apps or any of the Services for a reason other than a CityScan error, CityScan will not be nor will be responsible for any claim regarding that Account.

Conditions of sale of content for TourMakers

TourMakers, or users who create tourist content for places or creators of complete tours (tourist routes) with the CityScan platform, acknowledge that they are the authors and owners of the rights to these content and publish them on the platform under their sole responsibility. The prices assigned to the experiences and contents are the exclusive responsibility of the TourMaker, although CityScan offers general guides to improve the possibility of sale of these for the benefit of all parties. These prices may not be lower than the cost of the transaction corresponding to the publication and sale and CityScan will update these limits that the TourMaker may review on the platform prior to assigning the sale price of the Tour. The duration and size of the contents will be limited to the capabilities of the platform, which will be gradually expanded as technologies and costs allow. The quality of publishable content is the responsibility of the TourMaker, although CityScan offers general guidelines for improving it. In any case, CityScan reserves the right of publication and may at its sole discretion disassemble any content it deems inappropriate without being entitled to any type of claim by the TourMaker. CityScan will charge TourMaker the 25% fee for each sale of the content created by it that is made with the platform. CityScan will reimburse the TourMaker 100% of the first 3 sales discounted the applicable taxes as an incentive to start the operation of the TourMaker with CityScan. Refunds will be made directly to the account registered and validated by the TourMaker on the platform prior to the publication and activation of any content. These reimbursements will be made periodically, monthly during the first six months of operation with the TourMaker and this frequency may be reduced to a weekly frequency after this period.

Content purchase conditions for TourFinders.

TourFinders can use the CityScan platform (Site / Apps) to purchase the right to use unique tourist experiences at the prices published on the platform and which include all applicable taxes, through established and approved means of payment. These rights to use purchased experiences give you unlimited personal or family access to them as long as they remain users of the CityScan platform. The TourFinder can request a refund of the value paid for the right to use the experience in the first... days of the effective day of purchase without giving any explanation, although optionally CityScan welcomes all the feedback information that helps us to provide a better service. It is not allowed for any TourMaker or TourFinder user to extract, copy, publish or sell by any means the experiences or content obtained or purchased for their personal and family use from the platform.

Cancellation and / or suspension of account

CityScan reserves the right, at any time and at its sole discretion, to i) refuse to open an Account and / or close or suspend an existing Account without having to provide explanations in this regard; ii) transfer or license, without prior notification, the data relating to the user to any legal entity, in any country, always guaranteeing that said data is transferred and managed in accordance with current legislation, data protection laws or other similar regulations. Likewise, CityScan reserves the right to iii) suspend and / or terminate a user's account if it considers that there are reasonable grounds to be lieve that an Account is used, has been used or may be used for illegal, fraudulent, dishonest, or if any provision of these Terms and Conditions has been violated

Obligations of CityScan
